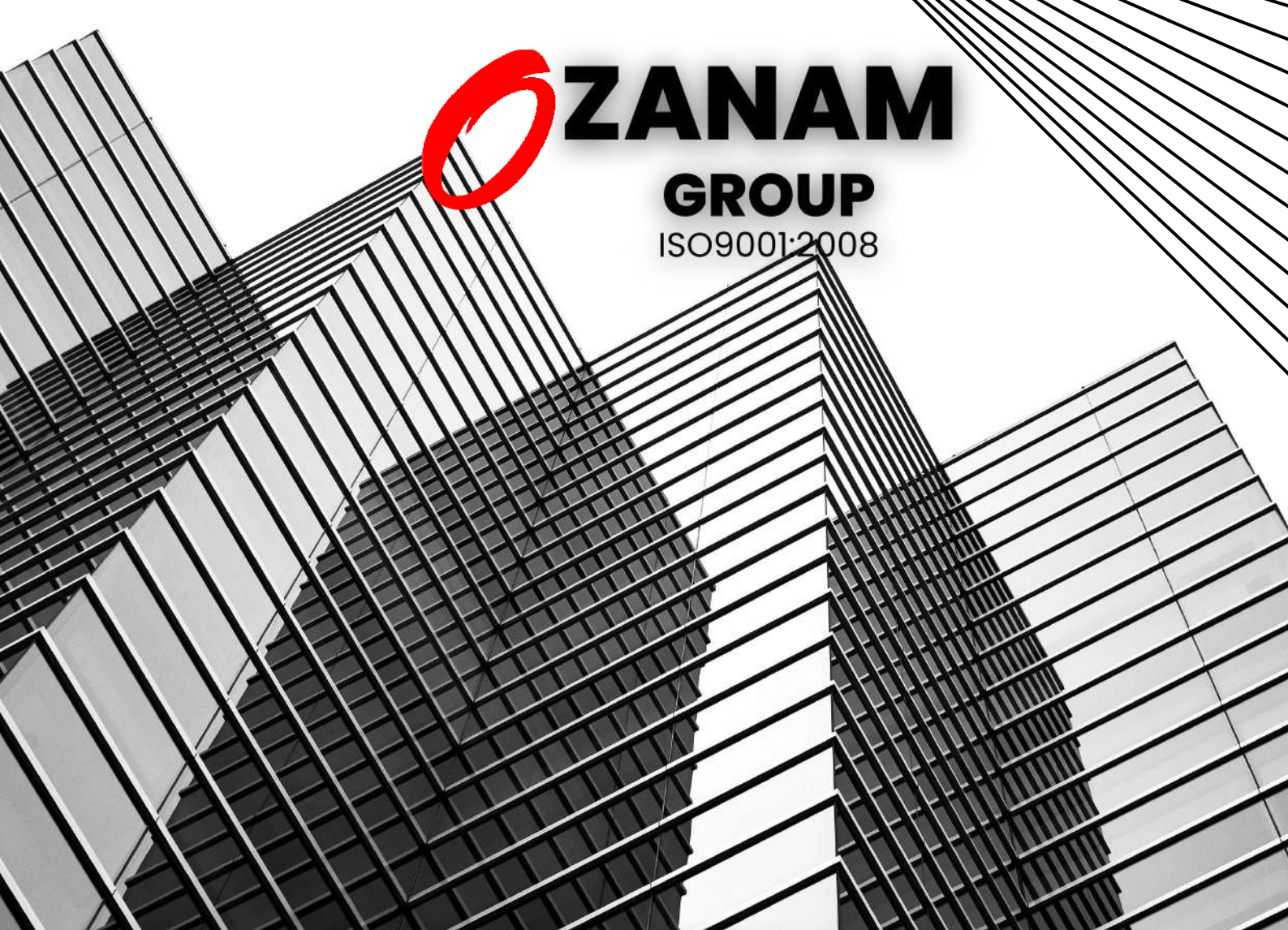

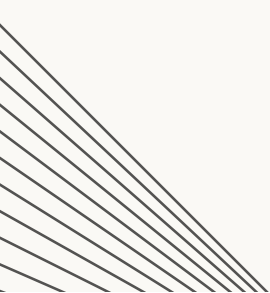

Ozanam is a multi business group which has been consistently recording turnover averaging around 10 crores for the past few years with its profitability increasing over the years which is well above that of its near competitors.



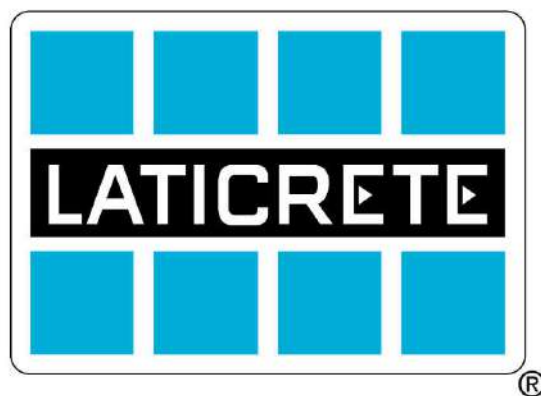
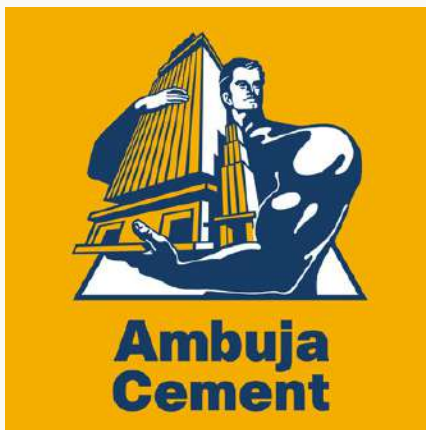
